Sub: Communication to combat spread of Novel Corona Virus (COVID-19)

Sir / Madam,

In continuation to this office earlier communication vide No 86-SS/E/20 dated 14/03/2020 and No. 87-SS/E/20 dated 15/03/2020 on the subject, it has been decided by the Hon'ble Chief Minister, West Bengal that the restriction imposed vide said communication is now being extended upto 15th April, 2020, in public interest.

2. Administrative departments of schools, Head of the institute including emergency services e.g. electricity, cleanliness, water supply, security etc may remain open as per local need to be decided by the head of respective institute

3. Hostels will also remain closed till 15th April, 2020 though, adequate arrangements as per the medical protocol will be made by the respective institute for the foreign students who are not able to leave the campus due to distance or otherwise. No visitor should be allowed during the period to visit the hostel, without prior approval of the Head of the Institute.

4. However, the Board Examination will be held as per schedule.
