THE WEST BENGAL COUNCIL OF RABINDRA OPEN SCHOOLING

NOTIFICATION

No. 666/WBCROS/2012.—20th May 2013.—In exercise of the powers conferred by sub-section (1) of section 41, read with clauses (xi) and (xii) of sub-section (2) of section 5 of the Rabindra Mukta Vidyalaya Act, 2001 (West Beng. Act XI of 2001), the Rabindra Mukta Vidyalaya, with previous approval of the State Government hereby makes the following amendments in Rabindra Mukta Vidyalaya presently the West Bengal Council of Rabindra Open Schooling as per "the Rabindra Mukta Vidyalaya" (Amendment) Act, 2006 (West Bengal Act XIII of 2006) (Admission and Examinations) Regulations, 2006 (hereinafter referred to as the said regulations) :

Amendment

In the said regulations,—

- (1) to sub-regulation (3) of regulation 17, add the following proviso :

"Provided that in respect of the students engaged as teaching Personnel attached to Elementary Education (from Class I to Class VIII), appointed on or after the 3rd September, 2001 and working in the Government or Government aided or unaided recognised institution, the facility of credit transfer under this regulation may be extended without any time limit for the purpose of up-gradation of their academic qualifications".

- (2) After the first proviso to sub-regulation (3) of regulation 31, add the following proviso :

"Provided furtherd that a student engaged as teaching personnel attached to Elementary Education (from Class I to class VIII), appointed on or after the 3rd September 2001 and working in the Government or Government aided or unaided recognised institution, who has passed in Uchcha Madhyamik Pariksha, desires to improve their score in any or all subjects in which they have already passed may apply for up gradation of academic qualification".

(3) for regulation 39, substitute the following regulation :

"39. Language of instruction.-

- (1) The question related to both the examination i.e. in Madhyamik & Higher Secondary Courses shall be set in English and Bengali Version in all subjects.
- (2) the subjects such as Hindi, Urdu, Nepali and Aloheiki also to be included in a language Group,
and
- (3) a student shall be eligible to write his answer in the Answer Scripts for his/her respective Examination in Bengali, English and Hindi Version".
- (4) for table 2, substitute the following Table :—
